PART I - FACTS

- 1. On February 11, 2004, third party Respondent Vidéotron Ltée was served with the Motion Record of Appellants by which such Appellants were asking the rederal Court for an order requiring certain productions by the Internet service provider business unit of the third party Respondent Vidéotron Ltée.

- 4. By letter dated February 17, 2004, the solicitor for third party Respondent Vidéotron Ltée confirmed to the solicitors for Appellants that third party Respondent Vidéotron Ltée would not oppose the granting of the order that was the object of the Motion Record of Appellants.
